Who's Who in choosing a new minister

1. The Patron

Each church has a Patron, who has the right to "present" a new minister. In many cases, the right belongs to the Queen or to the Bishop of the diocese. The Patron may, however, be a private person. This is so in our own case. The right has been in the family of Col. Weston for many years. He himself was actively involved in the appointment of Anthony and of Peter Robinson before him.

As the 9-00 congregation know well, Tony Weston, despite having a car journey of an hour and a half each way, worships with us regularly. We are blessed in having a Patron who has the interests of our church so much at heart.

2. The Bishop / Archdeacon

Every new minister coming to the diocese has to be licensed by the Bishop of Guildford. The Bishop will want to ensure that the interests of the diocese and of the wider Anglican church are being met when an appointment is made. Those interests may sometimes differ from those of the local church, and discussion will then be held between the Bishop, the Patron and the PCC.

The Bishop delegates much of his work to the Archdeacon of Dorking, the Ven. Julian Henderson, who has a close working relationship with the Churchwardens throughout the process.

3. The PCC

The PCC represents the local church in the appointment. In practice, it delegates the practical work to two of its members, who are the Parish Representatives. In our case, these will be people who can adequately represent each of our two congregations. The Parish Representatives are usually, but not necessarily, the Churchwardens.

4. The Churchwardens

Jill Davis and Peter Davies were appointed Churchwardens at our Annual Meeting in May. Whether or not they are our Parish Representatives, they will be responsible for maintaining church services during the interregnum, and for providing clergy whenever necessary, for example for communions, baptisms and marriages. At law, a churchwarden is an officer of the

Bishop, and is accountable to him, and to the Archdeacon, as to the state of the church and parish. Jill and Peter will endeavour to consult every part of the Church and community so that all views are represented. They have already started the consultation process by hearing the views of the new LiFE Leadership committee and starting discussions with leaders at the Church Leadership meeting.

Procedure and Timetable

1. The PCC will soon have two important meetings –

- a) a Vacancy Meeting on 19 June, when the Archdeacon will discuss the whole process of appointing a new minister with the PCC and the Patron;
- b) a follow-up Meeting on 10 July, to appoint the Parish representatives; to prepare a Parish Statement. This document describes the parish of West Horsley, the church buildings and Rectory, the Staff and other team members who help to lead our two congregations, the types of services

we have, a summary of our financial position, our Mission Partners, etc. It also identifies our core values as a church, our present needs and aspirations, and what we shall be looking for in a new leader. The document is important in focusing our minds on the future as well as the present. It is also a valuable guide for any candidate who applies for the job;

to ask the Patron to put in motion the search for a new minister. In practice, the Patron and the Parish Representatives and the Archdeacon will work closely together. The

search can be either by advertising and/or directly contacting those who may be interested.

2. At this stage, the Bishop may ask for a joint meeting of the Patron, the PCC and himself to put forward the needs of the diocese. If that happens, the search will be deferred until all the parties are agreed.

3. It is hoped that the search will result in some outstanding candidates being short-listed. We will produce another Newsletter at that stage to give you our thoughts on interviewing and selection.

Miracles, Signs and Wonders?

At the end of May I took a trip to Uganda. I went looking for miracles, signs and wonders; what I found was so much more.

Firstly I went to catch up on what my wife has been getting up to with the church plant in Luzira – and it is truly amazing. I spent the first week being thrown right into the deep end, on more than one occasion being given 5 minutes notice that I was 'to preach next', and yet I can honestly say that I have never **felt such an**

incredible anointing than in those times when, as I walked up onto the platform not knowing what I was going to say, I was totally dependant on God. Luzira is an incredible place, very hard to describe. 'Busy' comes close. I was struck by constant 'life' going on everywhere. Cars, horns blowing, motorbikes, their familiar buzz and hum, and people – people all over the place, busily hurrying about. All sorts of different people – rich and poor, lots of

very poor. In fact the thing that struck me most were the children of those poor families living out their lives in shacks built onto the back of the theatre that is now Faith Assembly Chapel. That week I was stretched in a whole load of areas – talk about breaking out of comfort zones. The Sunday morning service started at 10. I lead some worship, spoke a bit, went out with the children, came back in, spoke some more, prayed a lot, and finally left at gone 3 O'clock in the afternoon! "That's because it was raining" was the excuse the pastor gave. The people have nowhere to go if it rains. They don't have cars, if it rains they get wet, and that caring pastor didn't want them to get wet. So we didn't finish the service until the rain stopped!!



The Invisible Children

... and so to a district called Gulu, in the north of Uganda, to the centre of what has become famous for a war that has been raging for the last 22 years. A war using children as soldiers. This was the main reason for my trip. I had heard about this war last year when the team came from Canada. I was so appalled by the stories they told that I knew I had to do something. I could no longer sit back into my ignorant world and let this go on.

They're called *the invisible children*. Thousands of them. Tens of thousands of them. Children, who since 1986, when the conflict started, have been abducted from their homes or villages. One former young child soldier I met, now only 14, was taken as he went to collect water for his household when he was just 10 years old. He tells of the LRA (Lords Resistance Army) ambushing him as he carried his jerry-can. He was made to kneel down and told he would be shot if he tried to escape. I still find that too hard to imagine, yet his account was repeated again and again by the many former child soldiers I spoke to in the various rehabilitation projects I visited. Children, both boys and girls, are being abducted and forced into fighting and killing, or the girls into sex as the *'wives'* of the *'bossmen'* and yet it's never on the news. At some point, someone has to say **'enough, this incredible injustice against children has got to stop.'**

I spent that week in Gulu visiting a number of schools, other community projects and the NGO's (non government organisations) that are in place working against extreme odds to help. One manager from Save the Children in Gulu told me what they're able to do is merely 'a drop in the ocean.' But a drop causes ripples and a ripple works its way out until it affects things. Something is better than nothing.

I've seen the children. I've seen the fallout on their families and communities. I've met them, I know them – they're real and the pain is enormous. What did I find? That these people have more faith in God than you or I ever will have. They see God working in everything. They called me 'an angel sent by God' I hope and pray I can live up to that.

I took the trip because I believe that even one person can make a difference.

My journey has only just begun.... to be cont...
